

TECHNICAL AND SPECIAL SERVICES:

HUMAN INTELLIGENCE SERVICES: Under this kind of Services, we have Background checks, Duediligence, Employee Integrity Guarantee, and Industrial Intelligence, industrial planning and diesel theft and Invoicing Control Services.


